Description

The SKY85791-11 is a highly integrated front-end module (FEM) incorporating a transmit/receive (T/R) switch, a low-noise amplifier (LNA) with bypass, and a power amplifier (PA) for Wi-Fi 7 (802.11be) applications and systems.

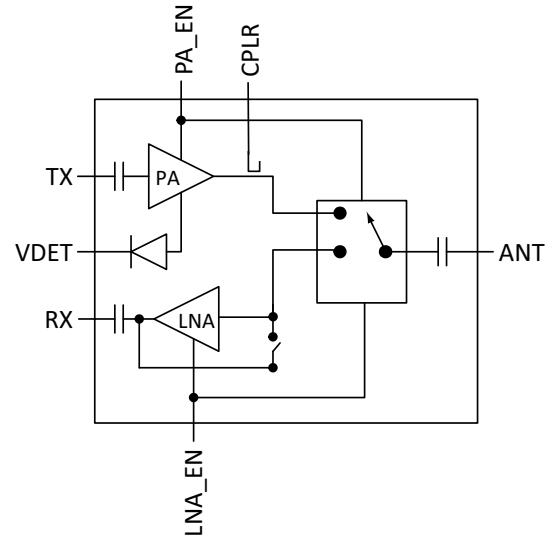


Figure 1. Functional Block Diagram

The PA output includes a coupler to allow for digital pre-distortion (DPD) in applications. In DPD applications, the coupler is also used in place of the power detector.

An integrated logarithmic power detector is included to provide closed-loop power control within the system. The device is provided in a compact 16-pin QFN package.

A functional block diagram is shown in Figure 1.
